the Maplewood Area Historical Society in August, 2023; and be it further

WHAT WE'VE BEEN UP TO...

Focusing on the Bruentrup Heritage Farm's rural roots, in 2022 we introduced the brand new Big Red Barn Farmers Market, showcasing our area's agricultural past and present.

We expanded our camps in 2022, and saw more than 100 children in our summer and fall day camps. By the end of the 2023 day camp season, about 220 children will experience day camps at our museum.

In 2022, we debuted our new St. Nikolaustag on the Farm celebration, which explored the history behind German-American holiday traditions.

We continue to enhance our programming, delivering mission-driven Summer Teas and events geared towards a wide range of audiences.

The recent donation of Lillie News materials bolstered our collection with more than 132,000 new artifacts and records.

At the Minnesota Alliance of Local History Museums' Annual Conference in 2023, MAHS was awarded two Minnesota History Awards; One award was given for Hmong Language & Culture Camp, and another was given for our new Nonprofit Leadership Internship.

PRESIDENT'S MESSAGE

It has been my pleasure to serve as Acting President of the Maplewood Area Historical Society (MAHS) during a period of great change.

I first found MAHS a year ago, as I was looking for a change. As a small business owner, I wanted to find an intimate, curated Farmers Market where I was part of a community first and the "soap and candle lady" second. When I walked onto the Bruentrup Heritage Farm, I knew I'd found that magical place. That change for MAHS a small Farmers Market at the farmchanged the lives of the small business owners who are part of the market community. We have met more than a few of the 13,000 visitors to the site, we have celebrated each other's victories, and know our customers as friends. I take such joy in watching their children grow, hearing from them about theater performances and hobbies, and answering their questions about my own family's activities.

Change, as we know, can also be hard. This was the year that MAHS finished its transition from a fully volunteer-run organization to one organized under a non-profit governance model with paid staff. As a Board, we worked with our staff to ensure that the changes we made to our processes and practices aligned with those of comparable non-profits. With that, we celebrated state-level peer recognition, began partnerships to increase our program offerings to more accurately reflect the diverse community that Maplewood and the surrounding community have always been.

Our membership now comes from across the United States. Our collection now includes over 130,000 items. Change, then, can also be beneficial. That growth, and the expansion of our reputation in the nonprofit world will help us continue to grow with intention.

With the help of our members and donors, we now are poised to take MAHS from a regional museum to one that is known nationally.

Thank you for being part of that journey.

EXECUTIVE DIRECTOR'S REPORT

2022 saw the Maplewood Area Historical Society turn the ripe ol' age of 25. We're a young organization in the world of historical societies and museums. As I look back at the first moments of our inception, the commitment and enthusiasm of a tiny but mighty group of Maplewood volunteers rings loud in our memory of them. During an era of great change for the City of Maplewood, a dedicated group of residents banded together to make sure our history and the stories of those who have come before is not forgotten, and took it upon themselves to form the Maplewood Area Historical Society in 1997.

Twenty-five years later, we are again at a point of great change—not for the City of Maplewood, but—for the Maplewood Area Historical Society itself. Two years ago I accepted the offer of becoming MAHS's first full time Executive Director. In these twenty-four months, we have seen change that is both exciting and sometimes anxiety educing for many of us in this room. As our head-gardener, Ted Hein has said "2022/2023 has been a year of corrections."

I remain proud to have driven history into everything we do, expand our fundraising, and reach more visitors at the museum than we have ever seen before. But my proudest achievement is the staff we have brought on to raise the Maplewood Area Historical Society to a level of professionalism that works to elevate us into the regional museum I hope our founders a quarter century ago would be proud of.

The growth and elevation of our organization into the realm of museums and nonprofits, has come with immense highs, but also the struggle of real work realigning our values to be a museum of choice where all staff, volunteers, and guests feel safe, respected, and supported. We represent the best that the Maplewood Area has to offer.

We began 2023 with approximately a \$112,000 deficit due—in part—to nonpayment of contracted funds by our former wedding coordinator, and the malfeasance of Board Members who placed their personal relationships with her and her for–profit business above that of their legal duty of care, obedience, and loyalty to the Maplewood Area Historical Society. Many difficult conversations were had, and in the end, anyone who had placed the Maplewood Area Historical Society in jeopardy, detriment, or risk stepped down from leadership roles.

This transition comes with great responsibility, difficult work, but also amazing rewards. The Maplewood Area Historical Society is viewed across the state as a museum of growth, innovation, and thought leadership. Why? Because what we do matters. The integrity we place as supporters of the organization over ourselves, matters. The community that depends on us to be a resource matters. This is why we work every day to meet our mission of educating, sharing, and preserving the history of the Maplewood Area.

This is why we matter. Good things to come.
